Good afternoon,

We would like to request a backfill at the pipeline leak at the Preston Battery (**2RP-4356**) on behalf of Lucid Energy. This was a natural gas release in which SMA sampled to ensure the soils around the release were clean.

We sampled the open excavation at 6' (BH) directly below the point of release, 2 of the sidewalls that were closest to the release point (SW1 and SW2), the spill pile (SP), and we also grabbed a background (BG).

Our initial investigation puts this location at a site ranking of 0.

I have attached the site map, summary table of the lab results, and the lab report.
