Is the proposal to leave impacted material at L1 and L2 in place, or am I missing something? Also, in the first paragraph, it states the site is on State surface. The "Release Information and Site Ranking" table indicates the site is on Private surface. My map shows it to be on private surface. Also, the site map shows "estimated release area". We will want samples from outside of that area for lateral definition. The last couple of things mentioned I could include as conditions of approval, but let me know the intent for L1 and L2, otherwise I would have to deny the proposal.
