Bruce,

Arcadis submitted the attached remediation proposal to OCD. The proposal is for a surface scrape of the pad, and then address remaining contaminants at time of closure. OCD will consider closure for this release with submittal of a Final Report C-141 indicating the pad scrape was performed.

There is also another release incident open on this site. It is **2RP-2677**. Basin Environmental did some work on that release and OCD approved backfill on September 17, 2015. That incident can be considered for closure with submittal of a closure report and Final Report C-141. (The well name was Crow Fed 35 at that time.)

Closures on Federal sites will require like approval from BLM.
