Louis,

I will send this one time to you as a courtesy but from here on OCD will no longer remain amicable to receipt of errored, missing, inaccurate documents submitted from Agua Sucia. Any further issues, concerns, or discrepancies will be immediately forward to the OCD Compliance and Environmental team in Santa Fe and/or OCD legal department.

When reporting a release to the OCD you will utilize a current C-141 it will be filled out with all the proper required data and, unless it is otherwise appropriate, releases are to be marked as Initial NOT Initial and Final. There are times where an Initial/Final submission is appropriate but NOT for the types of releases that have recently been reported by Agua Sucia. Please check our rules and regulations if there is any confusion on the matter of reporting to the OCD please see Part 29 – Release Notification (19.15.29 NMAC).

An Initial/Final may be appropriate to mark on the C-141 form in situations such as:

- All fluids remained in an SPCC lined secondary containment and all fluids were recovered and a full integrity check of the entire liner was conducted and any fill material present was removed hauled away and replaced.
- Reporting a release that involved a fire where no fluids hit the ground at all.
- And in a few other circumstances that may be more or less case specific...

Please review the information that has been provided and hopefully it helps to ensure more compliant future submission to the OCD.
