I have included a scanned copy of the signed Initial C-141 Remediation Permit along with an attached Conditions of Approval. The OCD tracking number for this event is 2RP-4208.

**PLEASE NOTE:** OCD has reviewed this API location and noted that there have been 7 documented spills that have involved either the battery site or the SWD well. OCD would like to, at this point, pose the question, to EOG Y Resources, of is there any intention to replace infrastructure for Compromise SWD # 1 and the tank batteries?

Also during my investigation of this file, I came across 2RP-2797 which had a DOR of 1/16/15 with 2500bbls of produced water from a hole in a surface supply line. After vigorous efforts by OCD members it was finally agreed upon that monitoring wells would be installed and it was claimed that a permit was applied for from OSE for said wells. The last document we have is a memo from Safety & Environmental Solutions proposing procedures for monitoring well installation. I have attached that document and the original C-141 above. Please expedite your efforts to provide an update on this matter as soon as possible.
