Amy,

I have included a scanned copy of the signed Initial C-141 Remediation Permit along with an attached Conditions of Approval (COA). The OCD tracking number for this event is 2RP-4552, please refer to this tracking number on any and all submissions sent in to the OCD. Please remit a site characterization plan (see COA document included in attachment) or advise OCD of plan of action by no later than 2/15/18.

Please note: I looked into our files for the above API and found this old case 2RP-3525 which contained a photo of the impact around the time after the release of 2RP-3525 occurred. I also then looked on Google Earth to see the state of this site currently and I attached that image as well. It appears that either attenuation has occurred here or that efforts were made to remedy this older release however I show no other records (other than the photo attached above) for this case. Can XTO please inform OCD on what has gone on for this location since 2RP-3525 occurred and if a remediation has not been completed for 2RP-3525 can we please include efforts on 2RP-3525 when efforts are made for the current case 2RP-4552.

Please advise OCD regarding this matter by no later than 2/15/18 as well.
