During flow back operations the KimRay pressure control valve to the sales line engaged and redirected sales gas to the flare line. Due to the high winds, the flare flame laid over and the heat caught the grass on fire off the edge of the pad. The flowback crews immediately choked back the wells then proceeded to use fire extinguishers to put out the fire. An 81'x27' area was affected. No fluids were released.
