Good morning,

Yesterday at 9:00 am, Operator reporting standing fluids in containment due to damage on the water leg going into the gun barrel and produced water tanks. The mounting brackets attached to the side of the tank parted and caused the piping to shift onto the catwalk, resulting in a connection leak into lined containment. Vac trucks were dispatched to location yesterday morning and have recovered 480 bbls produced water with two additional loads. High winds on 3/13 allowed a small amount of fluid to be released from the east side of containment.

The release remained on location. I will submit the initial C141 ASAP with final release numbers.
