I talked to Mike about this one to get his opinion. The Google Earth Image shows a tremendous amount of equipment and lines that run through this part of the location.

BBC International's delineation workplan report for the above release, requests full remediation activities until the decommissioning of this facility due to the existing production equipment and piping preventing full access. Please excavate and remediate the entire spill area depicted on the site diagram to a depth of 1 foot. The remaining contaminants and chlorides (SP1 – SP9) will be deferred until the site has a major well pad construction/alteration or abandonment, whichever occurs first. The areas have been delineated and documented in the report. At this time, OCD approves this request. The Final Report C-141 will be accepted for record and marked accordingly. The release will remain open in OCD database files and reflect an open environmental issue. This is a State site and will require like approval from SLO.
