Ashley,

LT Environmental's deferral request for the 2RP-5336, requests to backfill the existing excavation and complete remediation during any future major well pad construction/alteration or final plugging and abandonment, whichever occurs first. The areas requested for deferral are identified on the site map as soil samples SW04 through SW06, SW09, and SW12 collected from the final excavation extent. All areas within the pasture, except SS04 (near active flare stack) will need to meet reclamation requirements. The areas have been delineated and documented in the report. At this time, OCD approves this request. The Final Report C-141 will be accepted for record and marked accordingly. The release will remain open in OCD database files and reflect an open environmental issue. This is a State site and will require like approval from SLO.
