Victoria,

Here is the email from the BLM requesting the removal of impacted soils around the flowlines located along the edge of the lease road. To access the impact, we moved the flowlines and excavated the elevated chlorides up to lease road. These areas are sample points: SW-E1-1.25: 10,200 mg/kg, SW-E1B-1.25: 11,600 mg/kg and SW-E1C-1.25: 6,090 mg/kg. Based on the additional remediation activities, a revised report will be submitted for your review and should meet the criteria for closure of the site. Let me know if you need additional information, thanks

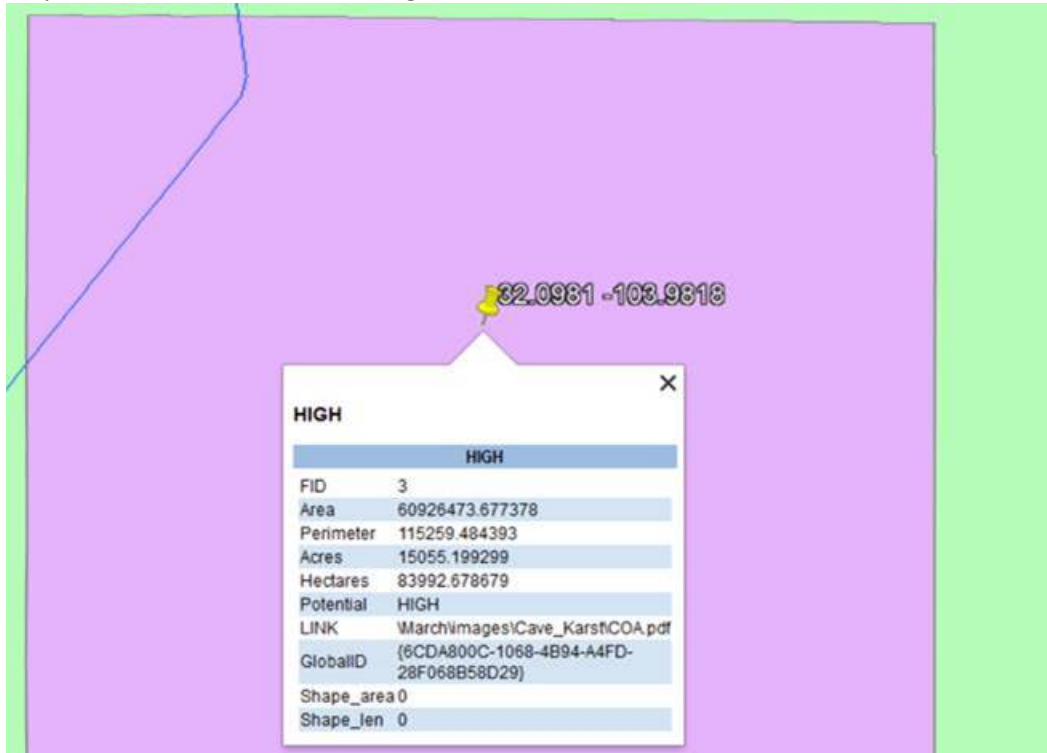

White Federal Com #001H (30-015-36185) 05-19-2019 2RP-5470

Mr. Tavaréz,
OCD has received your closure/deferral request for White Federal Com #001H (30-015-36185) 05-19-2019 2RP-5470, thank you. This closure/deferral is DENIED for the following reasons:

1. This site does not meet the criteria to apply for a deferral. By Rule NMAC 19.15.29.12.C.2: “ *If contamination is located in areas immediately under or around production equipment such as production tanks, wellheads and pipelines where remediation could cause a major facility deconstruction, the remediation, restoration and reclamation may be deferred with division written approval until the equipment is removed during other operations, or when the well or facility is plugged or abandoned, whichever comes first*”.
2. The release has not been fully delineated. By Rule NMAC [19.15.29.12](#): “*The DEFERRAL may be granted so long as the contamination is fully delineated and does not cause an imminent risk to human health, the environment or ground water*”.
3. This site is subject to the most stringent closure levels in Table 1. According to the latest version of BLM’s karst map, this site is located in the “High Karst area” which is considered an unstable area under NMAC Rule Part 29.

5. The Chloride concentration at sample points: SW-E1-1.25: 10 200mg/kg, SW-E1B-1.25: 11 600 mg/kg and SW-E1C-1.25: 6 090 mg/kg are unacceptably high.

More remediation effort should be made on this site. Considering this spill is located in a unstable area, OCD requests this site to be fully remediate to <50' closure standards in Table I of 19.15.29.

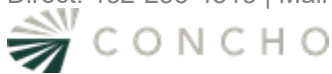
Mr. Hamlet,

Mr. Bratcher/Mr. Amos,

Please find the attached C-141 for your consideration. Also, attached is the calculation sheet to determine the estimated release volume. The liquid lost estimate is based on the spill dimensions, estimated depth of fluid (wet soil depth) and type of formation. The spreadsheet will calculate the volume lost in the ground and does not include the recovered amount in the calculation. The calculated volume in the ground and the volume recovered were added together and reported on the C-141. If you have any questions or concerns please do not hesitate to contact me.
