Mr. Gregson,

We cannot process your closure request because this report is incomplete. By Rule NMAC 19.15.29.12, for Remediation Plans and/or Closure Reports, the responsible party must submit a document that includes:

1. Scaled site map diagram with sample points clearly marked
2. Photographs of the remediated site prior to backfill
3. Site Assessment/Delineation summary (horizontal and vertical)
4. Delineation sample analytical results (lab tested)
5. Table containing analytical data
6. Description of proposed excavation depths corresponding to analytical table
7. Depth to groundwater evaluation, including fluid level data from New Mexico Office of the State Engineer or other documented evidence
8. Karst evaluation (see attachment)
9. FEMA National Flood map review
10. Signed and dated the corresponding part of form C-141 (Pages 3-5 for Remediation Plans or Page 6 for Closure Report)
