All,

XTO is requesting an extension at the EMSU SWD Injection-Circulation Line (Incident ID NRM2001058690) from the current 90-day deadline of February 1, 2020. The produced water release extended into surrounding pasture area located on Bureau of Land Management (BLM). XTO submitted an archeological survey and requested BLM approval to disturb the area of the release extent on November 13, 2019. On December 16, 2019 access to disturb the area was granted. XTO began further site assessment and began remediation activities on December 31, 2019. These activities are currently ongoing and the collection of final confirmation samples is expected to be complete within the next week. In order to complete the remediation work and submit a remediation work plan or closure report XTO requests an extension of this deadline until April 1, 2020.
