Cause of Release

We treated the well with chemicals to get the well producing more efficiently and in this process there was some scaling that was brought up with the liquids. This scaling caused the dump on the produced waterside of the separator to plug off sending all of the liquid to the oil dump. The extra liquid in the oil tank caused it to overflow the tank and push the oil into the lined containment around the tanks.
