All,

XTO is requesting an extension of the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Big Sinks 2-24-30 State Battery (2RP-5422). The release was discovered April 24, 2019 and initial site assessment began April 25, 2019. Fluids were released to the well pad and the pasture south of the well pad. A Right of Entry (ROE) Permit was submitted to the State Land Office (SLO) on June 28, 2019. The executed permit was received from the SLO on August 22, 2019. XTO began remediation activities in early November 2019 and continued through last week. Final laboratory analytical results were received this week. To provide enough time to fully review analytical data and complete a remediation work plan or closure report, XTO is requesting a 30-day extension of the deadline to March 24, 2020.
