All,

XTO is requesting an extension of the 90-day deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the JRU 21 SWD #1 (NRM2002747253). The release was discovered on November 27, 2019 when a pump failed releasing fluids into containment and onto the well pad. An initial site assessment was completed on December 9, 2019 however, drilling operations have been ongoing and to ensure the safety of all personnel and the environment, non-essential personnel are not permitted on site. This has prevented XTO from continuing remediation work. Regular updates of the operations will be provided to ensure that work begins as soon as the drilling and production operations are complete. A remediation work plan is being drafted to address this release along with several reported historical releases at this site. In order to ensure enough time to finalize the remediation work plan, XTO is requesting an extension of the deadline until April 25, 2020.
