The releases were discovered September 4 and September 9, 2019. WPX is addressing both releases simultaneously as they occurred in the same area. Initial site assessment was conducted from September 9, 2019 to September 12, 2019. Vertical and horizontal delineation of identified impacts have now been completed and WPX would like to request additional time to mobilize and complete remediation activities. WPX requests an extension of the current deadline until June 6, 2020 for both releases.

WPX is requesting an extension of the current deadlines of December 3 and December 8, 2019 for completing a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Longview Federal 12 #015H (2RP-5647 and 2RP-5630). The releases were discovered September 4 and September 9, 2019. WPX is addressing both releases simultaneously as they occurred in the same area. Initial site assessment was conducted from September 9, 2019 to September 12, 2019. Delineation activities were conducted using hand auger and potholing; however, additional time is being requested to schedule and mobilize a drill rig to the location in an effort to vertically and horizontally delineate identified impacts. WPX requests an extension of the current deadline until March 8, 2020 for both releases.
