All,

XTO is requesting an extension to the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Corral Canyon 10E Battery (NCS2002354093). The release was discovered December 22, 2019 and initial site assessment was conducted. Remediation activities are currently ongoing. Due to the proximity of production equipment some areas are scheduled to be treated with microblaze. In addition, the most recent laboratory analytical results indicated the need for further excavation at the site. To provide enough time for further site assessment, remediation work, and the completion of a remediation work plan or closure report, XTO requests a 90-day extension of the deadline to July 8, 2020.
