WPX is requesting an extension of the current deadline of November 21, 2019 for completing a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Swearingen #1 SWD (2RP-5628). The release was discovered August 23, 2019 and initial site assessment was conducted on August 27, 2019. Cleanup activities and initial delineation were conducted using hand auger and basic earth moving equipment. However, specialized drilling equipment will be required for full delineation, scheduling of this equipment has taken longer than expected. Due to the need for extra time to schedule specialized equipment required for full delineation, WPX is requesting an extension of the current deadline until January 21, 2020.
