All,

Pursuant to NMAC Section 19.15.29.12.B., XTO is requesting an extension of the current deadline of May 2, 2020, for submitting a remediation work plan or closure report at the Stan 32 State 71H (Incident ID NRM2004938133). On February 2, 2020, during drilling of the Stan 32 State 71H well, the drilling rig lost pressure and fluids surfaced on state land north of the well pad. XTO is conducting ongoing Electrical Resistivity Imaging (ERI) surveys on the well pad and pasture area north of the pad. The ERI reports will be used to evaluate potential subsurface impacts and guide remediation activities. A Right of Entry (ROE) Permit was submitted to the State Land Office (SLO) on April 27, 2020 to conduct further site assessment. An extension of time for completion of a remediation work plan or closure report is necessary to provide enough time for the completion of ERI surveys and additional site assessment activities, and ongoing remediation work. Based on the good cause shown, XTO requests an extension of the deadline to complete remediation or submit a remediation plan or closure report until August 2, 2020.
