At this time, XTO and LTE are discussing remedial options to address remaining impacts in an effort to ensure protection of public health and the environment, while remaining compliant with XTO's safety guidelines. To provide enough time for further site assessment, remediation work, and the completion of a remediation work plan or closure report, XTO requests an extension of the deadline to September 30, 2020.
