Mr. Hamlet,

Under the new spill rule a work plan or closure report is due for the above release on 8/5/19. COG has conducted some excavation at the release to eliminate the highly saturated soil. Samples were collected from the excavated area for evaluation. Additional delineation sampling is required however we are not getting cooperation from the pipeline companies in the area. The pipeline companies say they have to be present during excavation but won't make themselves available. Once we finish delineation we plan to conduct the remediation at risk. COG is requesting a three month extension until November 5, 2019 in order to complete delineation activities and either submit a work plan or conduct remediation at risk and prepare a closure report. Mr. Bratcher/Mr. Amos,

Please find the attached C-141 for your consideration. Also, attached is the calculation sheet to determine the estimated release volume. The liquid lost estimate is based on the spill dimensions, estimated depth of fluid (wet soil depth) and type of formation. The spreadsheet will calculate the volume lost in the ground and does not include the recovered amount in the calculation. The calculated volume in the ground and the volume recovered were added together and reported on the C-141. If you have any questions or concerns please do not hesitate to contact me.
