Good afternoon,

WPX had a spill last night, 10/31/18 at 9:30 pm, at the Santa Fe Fed 8 SWD. API # 30-015-27126, A-35-22S-28E. Injection pump stopped working due to power outage which resulted in overfilling the tanks. The majority of the fluids was contained inside lined SPCC containment berm; the berm overfilled and fluids impacted soil on the pad. 540 bbls were recovered from the containment and ~70 bbls off the pad. We will start the cleanup activities as soon as the line locates are completed.
