Your request for an extension to **November 27th, 2020** is approved. XTO is requesting an extension to the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at Poker Lake Unit 147-NRM2004445859. The release was discovered January 28, 2020 and initial site assessment was conducted. Following the initial assessment, remediation work was conducted by XTO. To date, an estimated 152 cubic yards of impacted soil has been removed and MicroBlaze was applied to areas where TPH impacts could not be accessed by heavy equipment. Laboratory analytical results are pending. The completion of a remediation work plan or closure report is still pending. As such, XTO requests a 90-day extension of the deadline to November 27, 2020.
