Your request for an extension to **December 29th, 2020** is approved. **This will be the final extension for this release.** XTO is requesting an extension to the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the PLU Pierce Canyon 28 Fed. There were two releases discovered between October 07, 2019 and November 13, 2019 that were assigned incident numbers NRM1931858285 and NCE2002742193, respectively. Remediation activities have been initiated but are currently suspended to review and address remediation efforts via excavation due to the amount of active production equipment and presence of shallow bedrock at the site. To date, approximately 55 cubic yards of impacted soil has been excavated. At this time, XTO is evaluating remedial options to address remaining impacts in an effort to ensure protection of public health and the environment, while remaining compliant with XTO's safety guidelines. Additional subsurface drilling is necessary to fully assess those options. To provide enough time for further site assessment, delineation and remediation work, and the completion of a remediation/delineation work plan or closure report, XTO requests an extension of the deadline to December 29, 2020.
