All,

XTO is requesting an extension to the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Corral Canyon Expansion. There were two releases discovered on July 21, 2020 and August 12, 2020. Initial site assessment was completed. Released fluids flowed into the pipeline right-of-way and into the surrounding pasture. XTO began remediation activities at the Site including excavation of impacted soils. To date approximately 3,690 cubic yards of impacted soil have been removed. The most recent laboratory results indicate additional remediation work is warranted. In order to conduct the remaining remediation work and draft a closure report or remediation work plan, XTO is requesting a 90 day extension of the deadline to January 17, 2021.
