Remediation Summary and Deferral Report was submitted to the NMOCD for approval. The report was denied by the NMOCD on July 2. 2020 due to the impact (V-1) not defined inside the facility containment. The impact was not vertically defined using a hand auger due dense formation. Further delineation (drilling rig) cannot be performed inside the facility due the lines and equipment limiting access to the area. COG had requested an onsite meeting with the NMOCD to inspect the area. The NMOCD did not respond to an onsite meeting. COG re-inspected area to determine if a drilling rig (air rotary rig) could access inside the containment. Upon further review, there appears to be small area inside of containment where we may access the drilling rig. The drilling rig has been scheduled and currently pending rig availability. COG is requesting a three-month extension until February 25, 2021 in order to inspect or perform the additional sampling at the site. Please contact me if you have any questions or concerns.
