Good afternoon,

EOG Resources Inc. respectfully requests a 60 day extension to October 25, 2021, for the completion of the Remediation Plan for the below referenced Incident ID. Currently the site is horizontally and vertically excavated, but due to the unseasonable amount of precipitation, confirmation sampling and backfilling of the excavation have been delayed. In speaking with the environmental consultant completing the remediation activities at this location, they believe 60 days will provide enough time to complete the confirmation sampling and backfill activities, as well as allow for the completion of the vertical delineation requested in the historical drill pit area. Those activities have also begun with field test results, map and table attached, exhibiting that all sample holes are delineated except for 1. The consultant is preparing to resample with a larger piece of equipment next week in an attempt to complete the delineation without having to bring in a core rig. If vertical delineation

can't be completed with the larger machinery, a core rig will be contracted to complete the delineation of that sample point.
