Our 90 day remediation due date for the subject incident is approximately 10/9/2021 – 10/12/21. The date of discovery on the C-141 is listed as 7/9/21 however, I can't find an approved C-141 on the Portal. It appears the NOR was submitted on 8/2/21. Would that give a us a 90 day completion of 11/2/21? We have diligently pursued remediation by delineating and hauling material. Our delineation samples are at the lab. We've had personnel shortages due to Covid as well as several weather events that have delayed our progress. For these reasons we are requesting a 30 extension on our 90 day incident closure deadline.
