- 1: Set a CIBP at 10,000' K.B.; cement on top as directed by the BLM.
- 2: Repair casing leak.
- 3: Perforate 8346' - 8354'; 8370' - 8372'; 7784' - 7786'; 7794' - 7800'; and 7808' - 7814' K.B.
- 4: Acidize and swab test.
- 5: Run potential test.
