## NOTICE OF VIOLATION - Inspection

Dear Operator:

Comments on Inspection:		Pumpjack is operating with slight leak from stuffing box. Hole has been dug around wellhead and has oil standing. Oil has been allowed at some point to run across location and out into pasture. Tank battery area has had releases that have allowed oil to run out of berm area, across pasture and onto well pad. Small unlined pit outside of fence on West end of battery has flowline with small steady stream of produced fluids going into it. Well site and battery is in violation of Rules 13, 115 and 116.
