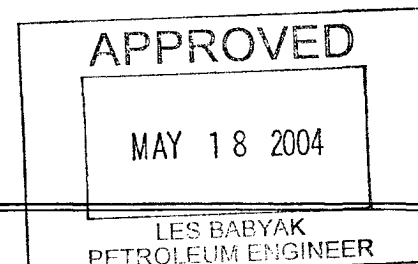

For well controll purposes Gruy is requesting to alter the casing design for it's Estill AD Federal # 2 as follows:

Set 40 # J-55 9 5/8" casing at 1550' and cement to surface with 1200 sx interfill C and premium plus.

Set 23# HCP-110 7" casing at 8000' with 8 3/4" hole and cement to surface with 900 sx of interfill C and premium plus.

Set 11.6# HCP-110 4 1/2" liner with 6 1/2" hole with top at 7500' and bottom at 13000'. Cement with 160 sx Super H.
