01/05-21/04 Drill out DV tool , test casing to 1000 psi for 15 mins- held ok. Drill cement to 5300'. Run CBL, TOC 615'. Perf 5283' to 5231' 6 holes @ 1SPF & 5212' to 5204'- total 16 holes @2 SPF. Run tbg, frac 5204' - 5283' 16,465 gals hot 20%HCL w/19,404 gals gel 2/100#/ gal 100 mesh sand & 2,000 gals cool 15% HCL. Install pumping unit, Test these zones to test tank. 1/22-31/2004 Pull tbg, set RBP, perforate 4830' to 4527' total 22 holes @ 2SPF. Acidize these perfs w/2000 gals 15% HCL. Frac these perfs w/56,658 gals gel w/34,944 gals hot 20% HCL w/5,100# 100 mesh sand. Finished w/5,000 gals cool 15% HCL. Run tubing to retrieve bridge plug, run 2 7/8" tubing and sucker rods. Turn well to Gissler A2 battery on 2/01/04.
