6/22/03 Perforated 4-1/2" casing at 1200'. Spotted 25 sx Class "C" Neat cement at 1243' to 865'. Perforated at 465'.

6/23/03 Squeezed 140 sx Class "C" Neat cement. Displaced to 350'. WOC 4 hrs.

6/21/04 Tagged plug at 193'. Perforated 4-1/2" casing at 150'. Pressured up to 1500 psi. Held for 10 mins. Circulated 15 sx Class "C" Neat cement at 193' to surface. WOC. Had cement behind 4-1/2" and 7" casing and 8-5/8" casing.

6/22/04 Cement at surface. Dug out cellar and cut off wellhead. Installed dry hole marker. WELL IS PLUGGED AND ABANDONED. FINAL REPORT.
