6/17/04 Drill 17-1/2" hole to 430'. Ran 10 jts 13-3/8" 48# H-40 STC csg. Total length 436.97', set @ 430'. Cmt w/ 300 sx of 35:65 POZ Class "C" + 6% gel + 6% NACL + 0.25 pps Celloflake, 12.5 ppg, 2.04 yld and 200 sx of Class "C" + 2% CACL2, 14.8 ppg, 1.34 yld. Returns in cellar. Circ 225 sx of good cmt in cellar. Bumped Plug - Held. WOC & temp survey as discussed w/ Mike Bratcher w/ NMOCD. TOC as per temp survey @ 40'. Ran 1" pipe & cmt w/ 150 sx of Class "C" + 4% CACL2, 15.0 ppg, 1.32 yld. Circ 75 sx of good cmt to cellar and between surface pipe & conductor to fill void. Pump 25 sx of same cmt to fill hole next to cellar boards outside of cellar. Mike Bratcher w/ NMOCD approved procedures on topping out surface pipe.
