Devon Energy Production Co., LP respectfully requests approval to TA the referenced well for five years, with annual casing integrity testing. The well was drilled in 1998, and is a poor performer. However, the well is located less than half a mile from the northern border of our West Redlake Unit (WRLU). As such, should the unit be expanded, the well would have immediate utility as a water injection well. Devon has other producing wells on this lease. TA procedure is as follows:

1. MIRU PU. TOH w/rods, pump and tubing.
2. RIH w/CIBP on tbg and set at +/- 1625'.
3. MI pump truck and hool up pressure recorder.
4. Test casing to 500 psi for 30 minutes.
5. Circulate hole with packer fluid. RDMO pump truck.
6. TOH w/ tubing, laying down. Close well in. RDMO PU.
