6-28-04 MI & RU Basic Energy. Tubing was parted 6' from surface. Could not run spear inside plastic coated tubing.
6-30-04 Dug out around casing. Cut 7" casing 8' from surface. Cut 5-1/2" casing & 2-3/8" tubing 7' from surface. Weld casing stubs back on.
7-6-04 Rig up, pick up overshot and latch on to tubing. Release packer and POH with tubing and packer. Pick up casing scraper. Trip in and out of hole. Tested tubing to 3000#, held okay.
7-7-04 RIH with injection packer. Circulated backside with packer fluid. Set packer @ 2852' and pressured up on backside. Wellhead was leaking, found hole in wellhead.
7-8-04 Install new wellhead. Tested backside to 500#, held okay. Rigged down and moved out. Shut well in preparing to notify OCD for new MIT.
