7/23/04 Set 9-5/8" 36# J-55 ST&C casing at 1432'. Cemented with 200 sx Premium Plus with additives and 800 sx Halliburton Lite Premium Plus with additives. Tailed in with 200 sx Premium Plus with additives. Cement circulated to surface. Tested casing to 1200 psi for 30 mins. WOC 26 hrs 45 mins. Reduced hole to 8-3/4" and resumed drilling.
