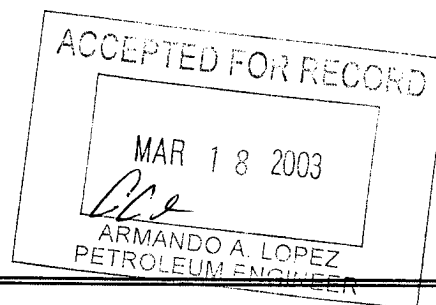

Tailed in with 200 sx "C" with additives. Circulated cement to surface. WOC 19 hrs. 50 mins. Reduced hole to 7-7/8" and resumed drilling.
