9/14/04 – Set 11-3/4" 42# H-40 ST&C 8rd casing at 430'. Cemented with 200 sx "C" Neat (yld 1.32, wt 14.8). Tailed in with 200 sx Class "C" with 2% SI (yld 1.32, wt 14.8). Cement circulated to surface. Had good circulation throughout job. WOC. Cut off conductor and installed flowline adaptor. WOC 19 hrs. Reduced hole to 11" and resumed drilling.

9/16/04 – Set 8-5/8" 24# J-55 ST&C 8rd casing at 1335'. Cemented with 300 sx 35/65 Poz "C" with 6% D20 + 5% D44 + 3% SI + .25#/sx D29 + .2% D46 (yld 2.1, wt 12.6). Tailed in with 200 sx "C" with 2% SI (yld 1.32, wt 14.8). Cement circulated to surface. WOC. Cut off and weld on 11" 3K head. WOC 25 hrs 15 mins. Reduced hole to 7-7/8" and resumed drilling.
