To final plug and abandon this non economic well bore.

On August 17, 2000 we set a 7" CIBP @ 2815' and dumped 35' of cement on top to shut off a water flow as per emergency verbal approval from BLM's Alexis Swoboda. The top of the cement plug is 2815' inside 7" casing. The top of cement is 2400' outside 7" casing. PRESENT WELL CONDITION IS SHOWN ON ENCLOSED WELL DIAGRAM.

WE WILL NOW COMPLETE PLUGGING AS FOLLOWS:

Perf @ 300' thru both casing strings and pump sufficient cement into 7" & 8 5/8" annulus and behind 8 5/8" to circulate cement to surface. If unable @ 300' we will perf @ 450' approx. and circulate cement in the annulus.

The surface location restoration will be done to the BLM requirements.
