Synthetic liner will then be placed over the drilling pit contents with a min. of a 3' over lap of the drilling pit area. The drilling pit will then backfilled back to grade using a min. of 3' of clean soil and like material, Mud seed will be applied in the proper seed mixture. A one call & 48 hour notice will be provide to the Oil Conservation Division before pit closure actions began.
