12/29/04 – Set 11-3/4" 42# HE casing at 604'. Cemented with 300 sx 35:65:6 "C" + 6% Salt + 3% CaCl2 + .2% Defoamer + .25#/sx D29 + 5#/sx gilsonite (yld 2.1, wt 12.6). Tailed in with 200 sx "C" + 2% CaCl2 (yld 1.32, wt 14.8). Cement circulated to surface. Tested casing to 1000 psi for 30 min. WOC 19 hrs. Reduced hole to 11" and resumed drilling.
