Devon Energy Production Co., LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in preapproved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108. The San Andres is perforated at 1890-2388' and the Yeso is perforated from 2923-3254'. Average production from the SA is 33 oil and 22 gas. Average production from the Yeso is 47 oil and 40 gas. The allocation method is by ratio of stabilized production. For the Yeso, oil is 58.8% and gas is 64.5%. For the San Andres formation, oil is 41.2% and gas is 35.5%. Commingling these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.
