Devon Energy Production Co., LP respectfully requests approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake-Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in preapproved pools or areas.

This pool was pre-approved by Division order PC-1108.

The San Andres is perforated at 1854-2444' and the Yeso is perforated from 2890-3368'.

Average production from the SA is 40 oil and 27 gas. Average production from the Yeso is 18 oil and 25 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 31.0% and gas is 48.1%.

For the San Andres formation, oil is 69.0% and gas is 51.9%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.

The BLM has been notified of this filing.
