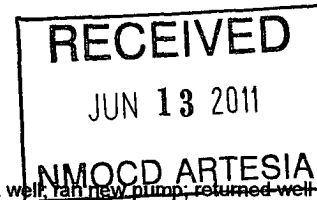
Dump acid job down annulus: 250 gal 15% HCl with 2% KCl flush.

Tested well at 1.68 BOPD
