AN IMPERMEABLE CONTAINMENT CONSTRUCTED FROM A TWO-COMPONENT MODIFIED POLYMER ELASTOMERIC LINING MATERIAL WILL BE RETOFITTED TO ASSURE CONTAINMENT OF ANY FUTURE CONTAMINANTS.
