6/29/11 to 7/21/11: Attempted to open & pump into frac ports @ MD9138', 8832', 8657', 8487', & 8279'. Due to major difficulties, Lime Rock decided to eliminate frac jobs through the first 4 frac ports. On 7/22/11, perfed 4-1/2" csg @ MD8245'-51' w/36-0.50" holes (bad frac port @ MD8279').

On 7/22/11, fraced horizontal lateral in 16 stages. Each stage consisting of 52,000# 16/30 Brady & 12,000# 16/30 cyberprop sand in 20# X-linked gel & preceeded by 1500 gal 15% HCL. Stage #1 through new perfs @ MD8245'-51'. Stage #2 through frac sleeve @ MD8108'. Stage #3 through frac sleeve @ MD7932'. Stage #4 through frac sleeve @ MD7717'. Stage #5 through frac sleeve @ MD7544'. Stage #6 through frac sleeve @ MD7372'. Stage #7 through frac sleeve @ MD7201'. Stage #8 through frac sleeve @ MD6984'. Stage #9 through frac sleeve @ MD6812'. Stage #10 through frac sleeve @ MD6638'. Stage #11 through frac sleeve @ MD6463'. Stage #12 through frac sleeve @ MD6250'. Stage #13 through frac sleeve @ MD6039'. Stage #14 through frac sleeve @ MD5784'. Stage #15 through frac sleeve @ MD5532'. Stage #16 through frac sleeve @ MD5200'. Drilled out frac ports to 18th port @ MD8657'. Decided to stop drilling.
