

<b>Describe Area Affected and Cleanup Action Taken.*</b> The spill impacted approximately 3,090 sq. ft. of caliche well pad. The free standing fluid was recovered with a vacuum truck and the saturated soil scraped up. Contaminated soil has been excavated and hauled to Lea land for disposal and the excavation has been backfilled with clean caliche. The impacted area complies with the NMOCD and BLM spill remediation guidelines.
