Describe Cause of Problem and Remedial Action Taken.\*

Ball valve failure occurred on wellhead allowing the packing to be pushed out, replaced packing and ball valve to alleviate problem.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 96' X 126' was affected around the wellhead. Vacuum truck was called to remove standing oil and backhoe called to remove impacted soils. Excavated soils will be hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. Analytical results show that TPH and BTEX are below RRAL for the site ranking (0) zero. All excavated soils hauled to a NMOCD approved facility. **Depth to Ground Water: >100' (approximately 170', Section 13, T18S-R29E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: > 1000', SITE RANKING IS 0.**
